ACCAHC Urges NCCIH Director Briggs to Name More Licensed Members of ACCAHC Professions to Its Council of Advisors

In a March 30, 2015 letter to the National Institutes of Health, ACCAHC submitted 15 excellent CVs of scientists licensed in one or more of the ACCAHC professions as nominees to the National Advisory Council on Complementary and Integrative Health (NCCIH). The move began in discussions in the ACCAHC Research Working Group, when co-chairs **Martha Menard, PhD, LMT** and **Cheryl Hawk, DC, PhD** learned that just 2 out of 18 members are from these fields. (Congress mandated "at least one half.") They began recruiting candidates and CVs. Following review from the ACCAHC Board and membership organization leaders, ACCAHC chair **Elizabeth A. Goldblatt, PhD, MPA/HA** and vice-chair **David O'Bryon, JD** sent a letter to NCCIH director Josie Briggs, MD with CVs of the individuals, below.

The letter stated, in part: "We earnestly believe that in fulfilling Congress' wish you will not only align the work of NCCIH with Congressional intent, but that by including more researchers from the licensed CAM professions in NCCIH deliberations, the Center will best advance the health of the public." Goldblatt and O'Bryon reminded Briggs that the NCCIH strategic plan states that "CAM practitioners are the key holders of knowledge related to the potential application of CAM interventions and disciplines." The two met with Briggs at the **Association of Chiropractic Colleges** March 2015 conference where Goldblatt and Briggs were each part of an opening panel. (See photo.) More news as it develops.

Public Protection Through Quality Credentials

A key step for optimal integration in patient care is getting members of ACCAHC disciplines through the doors of delivery institutions. Meantime, a major step for the economic well-being of ACCAHC professions is access to new jobs. IOM Invites Goldblatt to Make Pitch for Workshop on Self-Care, Wellness Health and Resiliency

In the initial April 6 call of the new ACCAHC-IOM Task Force (above), an almost unanimous turnout provided the ACCAHC team with direction for an April 22 planning meeting, and the April 23-24 Global Forum event, [Workshop on Envisioning the Future of Health Professional Education](#). A top focus: ACCAHC's member of the Forum, **Elizabeth A. Goldblatt, PhD, MPA/HA** was invited by Global Forum staff to make a 5-minute pitch to her fellow Forum members on why they should consider a workshop on the ACCAHC theme of "self-care, wellness, health and resiliency." This is one of five themes under consideration for a 2016 or 2017 workshop. Elevating the theme of health in health professional education is the core charge from the ACCAHC Board to Goldblatt and ACCAHC alternate member **John Weeks** in their work at the IOM. Goldblatt previously pitched the idea in the spring 2014 meeting. The ACCAHC team received some good suggestions from the Task Force and are collaborating on the message.



Association of Midwifery Educators Joins ACCAHC - Brings to 14 Core Members



The activism of ACCAHC board member **Nichole Reding, MA, CPM**'s inside her profession for more participation in ACCAHC is paying off! The presence of the direct-entry midwifery field in ACCAHC's work is growing. First, **Justine Clegg, MS, LM, CPM**, president of the **Association for Midwifery Educators** (AME) joined the IOM task force, above, as did **Sharon DeJoy, PhD, MPH, CPH, CPM**. Then ACCAHC received the great news that AME would join ACCAHC. Excellent! This brings to 14 of the 15 potential core members. (The one remaining is the North American Registry of Midwives.) A big welcome to AME! The ACCAHC Council of Colleges membership is now a full house of 5 core organizations.

Integrative Pediatrics MDs Group Taking Structured Input from ACCAHC Interprofessional Team

In mid-June 2015, a set of the nation's leading integrative pediatricians, led by **Larry Rosen, MD** and **Kathy Kemper, MD** will be part of a grant-funded Integrative Pediatrics Summit to set a course for their field. Though the gathering is MD-only, Rosen and Kemper welcomed an ACCAHC strategy to broaden input into the planning. ACCAHC Individual colleges' nominee to the Board, **Karen Bobak, DC, PhD** asked ACCAHC Individual College Members for interested parties. The ACCAHC Council of Colleges directors also recruited. Each of the following 18 professionals have filled out a pre-summit survey and will take part in a mid-May 2015, pre-Summit 2015 conference call and then a post-Summit call in July. Public Comment until May 20 to Influence the HHS National Pain Strategy: Consider a Response from Your School or Organization!

ACCAHC's member of the steering committee of the Pain Action Alliance to Implement a National Strategy (PAINS), **Martha Menard, PhD, LMT**, has forwarded a PAINS message urging public comment on [the draft National Pain Strategy](#). The strategy was recently published through the National Institute of Neurological Disorders and Stroke (NINDS) Office of Pain Policy. NINDS [published a notice](#) soliciting public comment to the document prepared by the Interagency Pain Research Coordinating Committee (IPRCC). The document follows-up the 2011 Pain Blueprint from the Institute of Medicine, on the committee for which ACCAHC placed **Rick Marinelli, ND, MAOM**. Comments must be received no later than 5 p.m. EST on May 20, 2015. ACCAHC is planning to submit through the Task Force on Integrative Pain Care, led by Menard, which produced the [Never Only Opioids policy brief](#) for PAINS. Let's get multiple voices calling for conservative care and supporting early use of non-pharmacologic approaches and practitioners.


