At the workshop we received copies of the report from the May 2013 3rd workshop for which Liza served on the planning committee. This is a bit of a celebration of our disciplines' presence in this Global Forum and of our successful insertion of our whole person, health-focused values. IOM Report on *Transdisciplinary Professionalism in Health* Features ACCAHC Disciplines and Values

In January 2012, the ACCAHC Board chose to bite the bullet and come up with \$30,000 to be a sponsor of the 3-year IOM Global Forum. One mundane motivation: to show up and insert the ACCAHC disciplines into the most significant international dialogue among health professions leaders. Another motivation is sublime: ACCAHC's representatives were charged to highlight whole person, health-focused, team-based values in this dialogue. We were to urge the "innovation" of prioritizing proactively creating health rather than reactively managing disease as the outcomes of health professions' education.

ACCAHC has carried the message of a health focus in multiple ways. (See, for instance, the IOM Member Spotlight on Goldblatt.) Now the report of the May 2013 workshop, IOM Destablishing Transdisciplinary Professionalism for Improving Health Outcomes, broadcasts the ACCAHC values. Included is a chapter on "Health and Well-Being in Transdisciplinary Professionalism." Goldblatt co-authored the section with ACCAHC Council of Advisors member, and workshop speaker Mary Jo Kreitzer, RN, PhD. ACCAHC recommended the topic and Kreitzer as presenter. The values come through. For instance:

- The ACCAHC fields "have more focus on the whole person and on health and wellness."
- The report notes that education in the licensed integrative health (ACCAHC) disciplines is more likely to focus on patients being "partners in healing" rather than as "passive recipients of care."
- The ACCAHC inclusion of a competency element related to self-care in the Competencies for Optimal Practice in Integrated Environments is noted.

The booklet is rich in thinking about an emerging era of "transdisciplinary" team care. It is available for download by <u>clicking here</u>.

Guide to ACCAHC-Related Content in the IOM Workshop Report

I went through the report to find all of the places where ACCAHC or ACCAHC work is directly featured. Some may seem miniscule. All, however, are about being in the game as a contributing influence in the health professions dialogue and workforce.

- -Copyright page, list of sponsors, ACCAHC, by alpha, is first.
- -Pg v, Planning Committee Member, Elizabeth Goldblatt listed with ACCAHC affiliation
- -Pg vi, List of Form Members, Elizabeth Goldblatt listed with ACCAHC affiliation



- -Pg ix, Acknowledgements, Liza listed in bottom paragraph
- -Pg 2-3, first # under "Health Care Structure," John Weeks and ACCAHC mentioned, introducing the topic of popular demand shifting practice, a discussion in the first paragraph regarding consumers driving inclusion.
- -Pg 5-3,4 Maryland University of Integrative Health student Eric Cohen, recruited through ACCAHC, in photo. (Note that his University affiliation for his "master's degree in nutrition and integrative health" is wrong and will be corrected in the final.) He speaks to the issues of "territory" as obstacle, and the importance of patient navigators in oncology.
- Pg 6-1,2,3 in Making It Real chapter, "Group 3: Health and Wellbeing" was created via Goldblatt and ACCAHC's work on the planning. Mary Jo Kreitzer, ACCAHC Council of Advisers member, is referenced. 6-2,3,4 is a chart that includes health and wellbeing content.
- -Pg 6-5, 6-7, 6-8 "Health and Well-Being in Transdisciplinary Professionalism" inputs into discussion, from my material led by Kreitzer and co-developed by Goldblatt. Topics include self-care, self-awareness, "just culture" and the definition of "wellbeing."
- Pg II-21 through II-25, in the section called "Papers and Commentary from Speakers," the paper co-authored by Kreitzer and Goldblatt: "The Case for Integrative Health, Well-Being and Self-Care into Health Professional Education". The 5 licensed "CAM" fields all mentioned by name in the context of not being as



"hierarchical" and in training to work as "partners in healing" rather than as "passive recipients of care." Also noted (pg II-22) was that these fields "have more focus on the whole person and on health and wellness" then noting that explicit "self-care tends to be absent from or minimal in curricula as well."

- Pg II-24, in the context of the "Core Competencies for Interprofessional Collaborative Practice" the ACCAHC work on "identifying core competencies for practicing in an integrated environment" is referenced. ACCAHC's additional competency elements added are noted "including the ability to demonstrate personal behaviors and self-care practices that reflect optimal health and wellness." This leads into a discussion about adding such competencies, and what they would be. The ideal of teaching these in an interprofessional context is noted.
- Appendices, A-3, in Workshop Agenda, Goldblatt and Kreitzer's roles noted
- A-4, Kreitzer's "report back" on the health and well-being topic is noted.
- Speaker Bios, B-6, Goldblatt, featuring her ACCAHC role(s).
- Speaker Bios, B-8, Kreitzer, featuring her CAHCIM role.

ACCAHC Community Chips in to Support John Weeks Role in IOM Panel on Assessment

The IOM contacted me as the ACCAHC executive director late in the week prior to the October 9-10 workshop on Assessment in Health Professional Education to see if I wished to participate in a short panel. I explained that all I lacked was expertise in academics, and in assessment. Yet, because it was a chance to make our work visible, I volunteered to contact ACCAHC leaders for input and serve as best as I could to report what they shared. I was in two 10-minute segments with three other panelists: a leader of the Canadian interprofessional education collaborative, a representative of the American Medical Student Association, and a leader with the National Academy of Practice. I was able to share:

- -The importance of clarifying desired educational outcomes prior to clarifying assessment strategic, together with ACCAHC's focus on *creating health* rather than disease procedures, and how this has been recently picked up by innovators at the Mayo Clinic.
- -Use of simulations including Objective Structured Examination (OSCE) and Primary Intern Clinical Evaluation (PICE) at Canadian College of Naturopathic Medicine as shared by **Nick DeGroot, ND**.
- The general trend toward using simulations as shared by **David Wickes, DC**, from the University of Bridgeport.
- -The systematic examination and re-formulation of institutional goals and outcomes to include the interprofessional competencies led by **Stacy Gomes, EdD** at Pacific College of Oriental Medicine.
- Use, by Bastyr University **Ryan Bradley, ND, MPH**, of the US Preventive Services Task Force 5-As (Assess, Advise, Agree, Assist, Arrange) as an assessment tool in clinical education to stimulate clinical care that focuses on fostering health habits.
- -A tool called Readiness Assessment Test used by the Alliance of Midwifery Education's **Wendy Gordon**, **LM**, **MPH**, to successfully foster better team care.


