- Jason Wright, LAc, Clinical Care Working Group, Jason Wright, MS, LAc, NCCAOM is the dean of the Finger Lakes School of Acupuncture and Oriental Medicine associated with New York Chiropractic College. **Weeks – interested?** (Opportunities in regional meetings in Seattle, Boston, Chicago, Tampa, San Diego) Steve Given, DAOM, LAc, the director of the DAOM program at Bastyr University and a leader of the Council of Colleges of Acupuncture and Oriental Medicine will john executive director John Weeks as ACCAHC's representatives to the national PAINs project. The 1st of 5 regional meetings will be held in Seattle on August 19, 2010. The PAINS project is:

"... a national initiative of the <u>Center for Practical Bioethics</u> to access the capacity and readiness of individual leaders and organizations to collaborate for the purpose developing a national strategic plan to improve the treatment of chronic pain." (The initiative is funded through Purdue Pharma.)

ACCAHC learned of the initiative via Rick Marinelli, ND, LAc, a past president of the inter-disciplinary American Academy of Pain Management. At the time, no individuals from the ACCAHC disciplines were slated to be participants. The program directors have asked ACCAHC for other nominees for meetings

## Via ACCAHC, U Bridgeport's Jennifer Johnson, ND invited to Health Coach

**Summit:** Jennifer Johnson, ND, a member of the faculty at University of Bridgeport's program in naturopathic medicine will also represent ACCAHC disciplines at the invitational Health Coach summit September 26-27, 2010. The group will develop standards for clinical health coaching. Johnson was nominated via Guru Sandesh Khalsa, ND, the program's dean and an ACCAHC Board member. Johnson will join Cheryl Hawk, DC, PhD and potentially executive director John Weeks, who was also invited. We plan to utilize the group of interested professionals as a response and input team as this multi-stage process going forward. **Let us know if you are interested or if you know someone in your field or institution who is significantly involved in the wellness/coaching arena.** 

Comment from Allina's Lori Knutson, RN Re: Federal Panels, Coaching Lori Knutson, RN, BSN, HN-BC, an ACCAHC adviser who is director of the nation's most significant inpatient integrative care program at Allina Hospitals and Health Care sent this note following the July 27 Tuesday Letter's news of ACCAHC nominees to federal posts, and the health coaching initiative:

A comment: There is a challenge, from my clinical perspective, that these [FEDERAL] panels will be very heavy on the academic represented side and minimally represented by the non-academic clinical environments of private and public hospital's/health care systems. The potential disconnect between policy, academia, and the lived clinical environment is concerning to say the least. Equal representation in areas of expertise is the desired outcome for true transformation.

Regarding the Health Coaching summit, we currently have 5 health coaches on staff and have taken the U of M CSH Health Coach students for semester clinical experiences. We have created a **healthcare motivational coaching curriculum** which focuses on the activation of an individual to sustain lifestyle changes which is not typically part of a health coach curriculum. I am also aware that 3rd party payers are training their own coaches with the focus on helping their members achieve the outcomes determined by the insurance company as pertinent.

I share this to demonstrate a little of the variety in the yet to be determined field of health coaching. What needs to be part of the curriculum development is a focus on what the gap is in individuals knowledge, skills and level of confidence to activate sustainable healthy lifestyles. Much of what I am seeing right now in health coaching approaches are based on the particular institutions goals are (often based on health care cost/utilization) instead of what will transform the consciousness that needs to occur for a healthy nation. **Knutson made it clear** that "this is not about being confrontational or adversarial. My intent is to express the less active voice of the clinical environment where the vulnerability and potential for individual health transformation can take place. I wish to advocate for more active input from the purely clinical provider perspective (and perhaps the clinical administrative perspective). Often clinicians with no academic or political association do not advocate for advancing their world; partly because they are just so busy doing the work."

- Northwestern University selects CEDR for Faculty Development Retreat Northwestern
   University of Health Sciences has decided to purchase 104 copies of the ACCAHC CEDR for a
   September 2010 "Faculty Development" retreat. Renee deVries, DC informed us of the decision.
- University of Medicine and Dentistry Institute for Integrative Medicine The CEDR will be a required text in CAM Seminar, required for Masters of Science in Health Sciences in Integrative Health and Wellness students. Karen Malone, MA and Adam Perlman, MD, MPH were the leads in this decision.
- CEDR teams estimate over \$6500 in sales for 2011 Preliminary estimates from Beth
  Rosenthal, project manager, are that the current schools in which the CEDR is required will
  generate roughly \$6500 in 2011 revenues. If 50% of the ACCAHC schools required the CEDR,
  ACCAHC would generate over \$50,000 annually to support its mission.
- Plans in development for CEDR as part of ACCAHC individual college membership drive The
  ACCAHC executive committee agreed in its executive committee meeting August 9 to
  recommend to the Board at its August 17 meeting a fall individual college membership
  campaign in which the CEDR will feature prominently. In effect, each school will have the chance
  to directly advance inter-professional education (IPE) in its students in the act of becoming a
