#### NUHS and Leo S. Guthman Fund Each Make \$30,000 Commitments to ACCAHC

- National University of Health Sciences (NUHS) the First "Gold" donor to the ACCAHC Center for Optimal Integration As announced first in the ACCAHC Annual Meeting December 1, Jim Winterstein, DC, NUHS president, and his executive team have committed to Gold level donor status for the ACCAHC Center for Optimal Integration (COI). The first \$10,000 of the 3-year grant-pledge of \$30,000 has already arrived. This is a wonderful, energetic start to our efforts to create this go-to site for all stakeholders in optimal integration arena. # What a Definition Means: ACCAHC 2005 Input on "Integrative Medicine" Definition in Fox News Article Lauding the Field

The 2nd paragraph of a recent Fox News article (Integrative Medicine May Be Just What the Doctor Ordered) evidences work by ACCAHC board members and our colleagues with the Consortium of Academic Health Centers for Integrative Medicine (CAHCIM) in 2005. The definition of "integrative medicine" in the Fox article, taken directly from the CAHCIM site, includes the inter-professional amendment that ACCAHC leaders recommended to their CAHCIM colleagues: "... makes use of all appropriate therapeutic approaches, health-care professionals and disciplines to achieve optimal health and healing." [Bolded words were included by CAHCIM leaders based on the ACCAHC recommendation.] The Fox News piece shows the ripple effects of an inter-professional agreement. Nice! New-comers to IM reading the piece will explicitly see the multidisciplinary nature of the field.

### **IOM Pain Committee Update: Opportunity for Input on Key Strategic Directions**

Rick Marinelli, ND, LAc, the ACCAHC nominee appointed to the IOM Committee on Advancing Pain Research, Care and Education will be asked for his perspective on the areas listed below of the Committee's inquiry. If you have suggestions, please send to <a href="mailto:jweeks@accahc.org">jweeks@accahc.org</a> and I will pass them to Rick. The Committee's work, part of the <a href="mailto:National Pain Care Policy Act of 2010">National Pain Care Policy Act of 2010</a>, will lead to a report to the Department of Health & Human Services, the NIH and Congress. The Committee is charged to:

- Review and quantify the public health significance of pain, including the adequacy of assessment, diagnosis, treatment and management of acute and chronic pain in the United States. This effort will take a comprehensive view of chronic pain as a biological, biobehavioral, and societal condition.
- Identify barriers to appropriate pain care and strategies to reduce such barriers, including exploring the importance of
  individualized approaches to diagnosis and treatment of pain.
- Identify demographic groups and special populations, including older adults, individuals with co-morbidities, and cognitive impairment, that may be disparately undertreated for pain, and discuss related research needs, barriers particularly associated with these demographic groups, and opportunities to reduce such barriers.
- Identify and discuss what scientific tools and technologies are available, what strategies can be employed to enhance
  training of pain researchers, and what interdisciplinary research approaches will be necessary in the short- and longterm to advance basic, translational, and clinical pain research and improve the assessment, diagnosis, treatment and
  management of pain.
- Discuss opportunities for public-private partnerships in the support and conduct of pain research, care, and education.

• Alliance for Massage Therapy Education Engages Teacher Standards Project ACCAHC Associate Member the Alliance for Massage Therapy Education has announced the launch of a National Teacher Education Standards Project. Executive director Rick Rosen, LMT, shares that the project's purpose is to "strengthen and improve the quality of massage therapy education by developing and implementing competency standards for teachers across the continuum of entry-level, continuing education and advanced training programs."  CNME, ND Accreditation Group, Announces 5 Year USDE Renewal Dan Seitz, JD, executive director of the Council on Naturopathic Medical Education (CNME) shares the following news with the ACCAHC community:

"CNME's latest re-recognition hearing happened just this past Wednesday: Rita Bettenburg [CNME president; ACCAHC EWG; primary care project] and I appeared before the National Advisory Committee for Institutional Quality and Integrity (NACIQI), which is the second-tolast step in the renewal of CNME's recognition as an accrediting agency by the U.S. Dept. of Education (USDE). We may have set a record for the shortest hearing ever: after a few brief presentations, the NACIQI members voted unanimously to recommend that the Assistant Sect'y for Post Secondary Education renew CNME's recognition for five years—the longest time allowed; also, they determined that CNME is in full compliance with their regulations. The whole hearing process took about five minutes. The Assistant Secretary now has 90 days on which to act on the NACIQI recommendation. We anticipate this final step will go smoothly ... A word of thanks to Rita: she has done a terrific job leading the Council." Seitz also thanks Karen Howard [AANMC executive director] and David Matteson: [AANMC consultant]: "They have over the years cultivated a positive relationship with senior staff inside the U.S. Dept. of Education, and have made USDE staff aware of the profound difference between the ND programs we accredit and the abbreviated and diploma mill programs that generate so-called 'traditional naturopaths.""

  that acupuncturists have been granted privileges to the embryo transfer (IVF) suite in the
  Operating Room of the University of Colorado Hospital: "We are now coordinating on-call TCM
  care with the Endocrinologists of Advanced Reproductive Medicine and on the date of embryo
  transfer we are performing acupuncture before and after that procedure to increase the
  embryo's chances to become a baby."
